### **Director's Updates**

#### March 1, 2024

### **Executive Director & Bureau Chief's Report**

March 1, 2023

### **Scholarships & Grants**

The Bureau of Iowa College Aid's scholarships and grants team has continued its work of directly supporting Iowans' pursuit of postsecondary education with funds through the state's scholarship and grant programs.

At the last Board of Commissioners meeting, two administrative rules were adopted that allowed us to proceed with making awards for the fall semester under the Future Ready lowa Grant and the lowa Workforce Grant and Incentive Program. Section Chief Todd Brown will go into greater detail on the success of the lowa Workforce Grant and Incentive Program later in the agenda.

Staff was also able to use additional funds to eliminate a waitlist for the Karen Misjak GEAR UP Iowa Scholarship and provide the waitlisted students with funds to attend an eligible college or university. Last year, more than 2,000 Iowans received the scholarship.

Applications are also open for next year's scholarship and grant programs as staff begins assessing applicants and making awards. Recently, we notified the Teach Iowa Scholar Award recipients of their selection. A total of 185 Iowa teachers will receive the award. Of those awards, 51 are new recipients, and 134 are renewal awards. More than 650 Iowans applied for the program this year.

The applications for the Health Care Award Program, Health Care Professional Recruitment Program, Mental Health Professional Loan Repayment Program, and Rural Iowa Veterinarian Loan Repayment Program remain open.

Staff is also processing data from the recent initial spring semester scholarship and grant reporting deadline that passed in February. This deadline is for institutions participating in scholarship and grant programs administered by the Bureau of Iowa College Aid. We are now validating the reported data and using the disbursement data to update expenditure projections for each program. This process is one of 12 official checks on spending levels during the academic year.

#### **GEAR UP Iowa**

As staff deployed GEAR UP Iowa 3.0 programming to partner districts, they continued to efficiently and expertly host events to support current GEAR UP Iowa students and families throughout the fall and winter.

GEAR UP Iowa's fall campus visits concluded with nearly 200 students from 15 GEAR UP Iowa schools visiting Iowa State University. The fall's six official campus visits helped approximately 600 students experience college campuses across Iowa.

As the calendar turned to 2024, we have been busy hosting a series of Family Nights and orientation events for GEAR UP lowa 3.0 students and families to introduce them to the GEAR UP lowa program and what they can expect from our services and supports.

To date, these events have taken place in Burlington, Saydel and South Tama. In addition to educating students and families, they serve as a celebration of the opportunities presented to these students and their future successes. We have also met secondgeneration GEAR UP lowa students whose parents were members of previous GEAR UP lowa cohorts and benefited from exposure to earlier iterations of GEAR UP lowa.

### Local College Access Networks

The Local College Access Network staff continues their efforts to create cross-sector collaboration in LCAN communities and continues to see many of these initiatives come to fruition.

The program is also busy planning its 2024 LCAN Conference this month. Scheduled for March 19 in Des Moines, the event will provide a valuable opportunity for continued collaboration and training for LCAN coordinators and leadership.

### Course to College Coaching / AmeriCorps

lowa College Aid's AmeriCorps student leader and college coach program continues to be one of the top examples in the nation as staff is regularly asked to present on the topic and lead discussions on how they spearhead this successful program.

Student leaders have regularly engaged their fellow students and communities throughout the winter in planning FAFSA completion events, scholarship assistance, and college application assistance.

Recruitment for both programs is open for next year. Any interested high school students, college students, or recent graduates are encouraged to contact staff to learn more.

#### **College & Career Readiness Academy**

The Iowa College & Career Readiness Academy is excited to offer a new course for those teaching English Language Learners (ELL). This course identifies challenges and potential barriers unique to families new to the U.S. or students developing their academic English language proficiency. The curriculum targets actions that schools can take to support English Learners better as they work toward graduation and prepare for their transition to college or career training programs.

Unlike other Academy courses, this offering is entirely asynchronous. There is no start/end date; participants can enroll and complete the facilitated course at their own pace around their busy schedules.

### **Postsecondary Authorization**

The Bureau of Iowa College Aid's postsecondary authorization team recently earned a \$7,500 grant from The National Council for State Authorization Reciprocity Agreements (NC-SARA).

The grant will be used for professional membership in the National Association of State Administrators and Supervisors of Private Schools (NASASPS) and to attend the NASASPS annual conference in April 2024. Portions of the grant will also be used to improve the student complaint form and process via Salesforce.

Staff was also recently notified that Shiloh University, which announced its planned closure in 2022, recently completed its teach-out plan. Shiloh notified the Bureau of Iowa College Aid staff that as of Dec. 29, 2023, all students had completed their program of study, and grades had been posted.

All student records have been transferred to the University of Iowa. The staff has updated states that had State Authorization Reciprocity Agreement (SARA) students in the teach-out program and updated all Shiloh University records, including SARA, to reflect Shiloh's closure.

The postsecondary authorization team has also been highly active in following recent U.S. Department of Education negotiated rulemaking sessions related to state authorization and are following developments in this space exceptionally closely.

### FAFSA Update

As expected, the anticipated delays in releasing the 2024-25 FAFSA from the U.S. Department of Education have stressed the college application and financial aid process tremendously. We will not have a better idea of the actual impact this will have on FAFSA completion efforts for a few more weeks as the release of FAFSA data to financial aid offices and Iowa College Aid has equally been delayed until mid-March.

The Bureau of Iowa College Aid also utilizes the FAFSA as the primary application for many state-funded scholarships and grants. Staff use data from the application to qualify students for state aid programs and communicate their eligibility to institutions. Staff also utilize FAFSA application trend data to develop expenditure projections to establish maximum awards, filing deadlines, and other state scholarship and grant program criteria.

In light of this uncertainty, our entire staff has redoubled its efforts to communicate changes to the FAFSA and provide guidance to students, families and school staff to aid in navigating what has been a very frustrating FAFSA season for all parties involved.

As part of those efforts, a barrage of text updates have been sent to those who opted into our FAFSA texting campaign and Virtual College Coach. In addition to providing updates to the FAFSA timeline, the campaign shares infographics on what to expect from the updated FAFSA, the expected changes, why to file, and issues many filers are encountering.

Work also continues behind the scenes to ensure that every public high school in Iowa receives updated FAFSA reports once the data is available.

The Bureau of Iowa College Aid is also helping support the Iowa College Access Network (ICAN) to drive FAFSA completion efforts across the state. A collaborative grant program recently offered funding to communities to support FAFSA training and completion events hosted by the Iowa College Access Network (ICAN).

The funds have aided in hosting large and small-scale events that otherwise would not have been possible.

For instance, the Story County LCAN used the support to coordinate FAFSA events on a larger scale at various schools around the county, reaching many families in smaller communities that otherwise would not receive the needed services.

In January, our partnership with ICAN celebrated the third-annual FAFSA Awareness Week. Throughout the week, the staff hosted webinars on creating FSA IDs and preparing for the FAFSA, a step-by-step FAFSA completion event, and high school FAFSA resources.

In addition to the state-wide virtual events, Iowa College Aid staff also helped facilitate inschool FAFSA completion events at Columbus Community High School, Crestwood High School, Griswold Jr.-Sr. High School, Ottumwa High School, Lisbon High School, Storm Lake High School, Bedford High School, Calamus-Wheatland High School, Iowa City West High School, South Tama County High School, Colfax-Mingo Jr./Sr. High School and Greene County High School.

Many convenings, led by our staff, have also occurred among college access professionals to strategize and discuss best practices and steps to assist students, families, and school counselors in overcoming the challenges they are facing. We will share more later during the agenda on this unanticipated FAFSA delay and our continued efforts.

### Staff Update

The entire Bureau of Iowa College Aid staff successfully moved to the Grimes Office Building on the Capitol Complex in January. This months-long process completed one of the final steps in the more extensive realignment of Iowa College Aid within the Department of Education. Thank you to the Iowa College Aid and Department of Education staff for their tireless efforts in making this a fruitful and successful physical transition of our staff, assets and efforts.

Merima Selimovic, Iowa College Aid's executive officer, recently decided to pursue a new journey. She was instrumental in all Iowa College Aid's programs, especially in administering the Board of Commissioners and its meetings. We wish her well in her continued endeavors.

### Call to Order

The Iowa College Student Aid Commission met for a regularly scheduled meeting Nov. 17, 2023 at the Commission's office. Commission Chair Stork called the meeting to order at 10:01 a.m. with roll call. A quorum was present.

#### **Executive Director & Bureau Chief Report**

Acting Executive Director and Bureau Chief Julie Ntem presented the Executive Director & Bureau Chief Report. She announced that the Bureau recently received reallotment funding for the Education Training Voucher (ETV), which serves students who aged out of the foster care system or were adopted after age 16. The funding eliminated the current waitlist of nearly 30 students and provided additional funding for other students who may qualify before the program's Dec. 1, 2023 deadline.

Ms. Ntem added that the Future Ready Iowa Grant resumed accepting applications in October. In the first few days the application was open, approximately 150 applications were received for the program. The Future Ready Iowa Grant is a state-funded program for Iowa students who are age 25 or older and attend an eligible school.

Ms. Ntem said the Bureau's scholarship and grant team member Tristan Lynn recently presented at the Iowa Association of Financial Aid Administrators (IASFAA) Fall Conference. Mr. Lynn presented on the Iowa College Aid Processing System® (ICAPS®) and provided an update on state-funded scholarship and grant programs.

Ms. Ntem announced receiving a \$25.8 million competitive grant from the U.S. Department of Education to the GEAR UP Iowa program. This grant will provide funding and support to 13 Iowa school districts over a seven-year period. This is the third competitive GEAR UP grant awarded to the state. The GEAR UP Iowa program will follow a cohort of current seventh-grade students through high school graduation in 2029 and into their first year of postsecondary education.

Ms. Ntem said the current GEAR UP Iowa Future Ready programming continued with campus visits and career exploration experiences. In the previous two months, students experienced campus visits at the University of Iowa, the University of Northern Iowa, Iowa State University, Eastern Iowa Community College, Grand View University, Kirkwood Community College, Iowa Central Community College, and La' James International. Career site visits included Barnhart Crane and Rigging, Mid-America Carpenters, Local 91 Sheet Metal Workers, Sexton Ford, and Local 25 Plumbers and Pipefitters. She said staff participated in Clinton's Career & College Planning Family Night, engaging with students and families about upcoming FAFSA changes, the GEAR UP Iowa program, and the Bureau's Virtual College Coach program. Ms. Ntem added GEAR UP Iowa staff attended the GEAR UP West Conference in Spokane, Wash., to learn best practices, participate in breakout sessions, and visit nearby college campuses.

Ms. Ntem shared that the Local College Access Network (LCAN) team recently visited the newest LCAN, the Ignite Pathways Regional Center. Based in Woodbine, Iowa. The Ignite Pathways Regional Center allows students to take individual courses in an area of interest while still enrolled in their current school district. Students can also attend and graduate from Ignite Pathways as full-time students.

Ms. Ntem said one of the former LCANs in Franklin County demonstrated the long-term sustainability efforts the program strives to achieve with the Greater Franklin County College and Career Fair at Hampton-Dumont High School. The event started in 2021 as part of LCAN programming and continues to help students learn more about career opportunities and develop soft skills in engaging and networking with college and business professionals.

Ms. Ntem stated that Course to College continues to deliver its programming to Iowa schools and provide resources to teachers and school counselors through weekly calls and opportunities to collaborate. The Bureau produced a 'Better FAFSA Social Media Toolkit' to assist stakeholders in spreading FAFSA messaging through social media platforms in their communities. The toolkit has received universal praise and has already been deployed by many educators across Iowa. Additionally, the National College Attainment Network (NCAN) has recommended the toolkit to its membership and featured it on the NCAN website.

Ms. Ntem said Danielle Sampson recently presented at the AmeriCorps program launch on the evolution of the Bureau's AmeriCorps program and the changes she spearheaded to better serve lowans in pursuing and attaining postsecondary education. Course to College Coach Levi Kirkpatrick also represented the Bureau and its services at Monticello High School's college and career fair.

Ms. Ntem announced the Iowa College & Career Readiness Academy is in the midst of its second fall session with three courses underway. The courses may be taken for license renewal, graduate credit, or for no credit (free) through AEA Learning Online.

Ms. Ntem said staff attended the National College Attainment Network's (NCAN) National Conference in Dallas, Texas. Thomata Doe, Liz Yaddof and Megan Sibbel were among the more than 1,300 college access professionals from across the country to convene for three days of workshops, discussions, plenary sessions and networking opportunities. Ms. Doe also presented at the 2023 Colleges to Counselors event at Simpson College. She provided details on the success of the Bureau's Summer FAFSA Associate program and how to maximize Course to College programming.

Ms. Ntem announced that the committee reviewing lowa's boards and commissions recommended no change to lowa's affiliation with the Midwestern Higher Education Compact (MHEC). This recommendation allows the state of lowa to continue its membership in the state reciprocity agreement with NC-SARA without interruption, as state membership or an affiliation agreement with one of four regional compacts is a prerequisite for a state's membership with NC-SARA. Consequently, lowa institutions experienced no change in their SARA participation.

Ms. Ntem stated 54.7 percent of Iowa's high school seniors from the class of 2023 have filed the FAFSA for 2023-24 as of Oct. 11. This is up 0.4 percentage points from this time last year. According to Federal Student Aid, the national filing rate as of Sept. 22 was 58.7 percent, up 3.1 percentage points from this time last year.

### **Director's Updates**

Commissioner Snow congratulated the Bureau on the receipt of the GEAR UP award and thanked the staff who assisted with the application. Commissioner Snow highlighted that the program will begin by serving 26 middle schools across 13 school districts and providing wraparound services to over 7,500 students.

Commissioner Snow provided an update on the hiring process for the Executive Director & Bureau Chief vacancy. In response to a question from Commissioner Quirmbach regarding the selection process, Commissioner Snow shared that a confidential team is scoring applications and the interview team will include Commissioner Stork, Commissioner Mulholland, and Commissioner Fitzgibbon as well as Ms. Ntem and Commissioner Snow.

#### **Meeting Minutes**

Motion: Commissioner Shull moved to approve the Sept. 15, 2023 Meeting Minutes as written. Commissioner Mulholland seconded the motion, which passed unanimously.

#### Administrative Rules

Mr. Brown provided background on the proposed rules changes for Chapters 10, 16, and 34. He shared that the proposed rules have passed through public comment and two public hearings. He added that no comments had been received, the Rules Committee

had no concerns, and the Governor's office approved a waiver allowing the rules to be filed into effect immediately upon approval.

Mr. Brown stated he will file the rule after adjournment to begin immediate awards to lowa students qualifying for programs impacted by these rule changes.

### Staff Reports

Mr. Lewis presented the updated financial report. In response to a question from Commissioner Fitzgibbon, Mr. Lewis verified the balance was presented on a cash basis. In response to a question about interest, Mr. Lewis explained that interest is deposited around the last day of each month.

Ms. Pundt provided the Postsecondary Registration, SARA and Exemptions report. In response to a question from Commissioner Fitzgibbon, Ms. Pundt verified that there are no University of Phoenix campus locations open in Iowa. Ms. Pundt shared that the team is observing several institutions and described the process for contacting Iowa students if there are concerns. Commissioner Quirmbach asked if there were any Iowa schools with financial concerns. Ms. Pundt stated no Iowa schools are of concern at this time, and out-of-state schools of concern are being watched for merger or change in ownership rather than financial concern. Commissioner Quirmbach requested a summary of the additional transparency being provided on the NC-SARA website regarding school concerns.

Ms. Sibaouih shared details on the GEAR UP Iowa 3.0 program that started Oct. 1, 2023, including grant requirements, the districts and students served, and anticipated program impacts. She highlighted the Iowa application was the only one to earn a perfect score out of the 11 state programs applying for grant funding. Ms. Sibaouih demonstrated the need for GEAR UP Iowa programming through data showing participating school districts having a higher occurrence of underrepresented minorities and free and reduced-price lunch participation than state average, as well as lower high school graduation, FAFSA completion, postsecondary enrollment, and postsecondary completion rates. She provided a high-level budget review and information on the scholarship assistance included in program requirements.

### Audit & Finance Committee Report

Commissioner Fitzgibbon provided a brief summary of the Audit & Finance Committee meeting, noting he had nothing to add to Mr. Lewis's financial report.

Motion: Commissioner Fitzgibbon moved to approve the administrative rules as written. Commissioner Shull seconded the motion, which passed unanimously.

#### Legislative Committee Reports

Commissioner Mulholland provided a brief summary of the Legislative Committee meeting, noting there was nothing to add to Mr. Brown's presentation on administrative rules.

#### **Commissioner Comments and Adjournment**

Ms. Ntem reminded Commissioners that the Postsecondary Attainment Institute meeting will occur after the Commission meeting adjourns, using the same Zoom link. The meeting adjourned at 11:16 a.m.
