CHAPTER 3

DECLARATORY ORDERS

281—3.1(17A) Incorporation by reference. The Iowa department of education adopts, and incorporates by this reference, the Uniform Rules on Agency Procedures for declaratory orders, effective on July 1, 1999.

281—3.2(17A) Additional information concerning declaratory orders. For purposes of Uniform Rules on declaratory orders, the following additional terms apply.

1. The designated agency is the Iowa department of education.

2. The department's designated office is the Grimes State Office Building, Second Floor, 400 E. Fourteenth Street, Des Moines, Iowa, 50319-0146.

3. The department provides required or optional notice of the petition within fifteen days of its filing.

4. The deadline for a petition in intervention under model rule X.3(1) is fifteen days.

5. Inquiries concerning the status of a declaratory order may be directed to the department's General Counsel at the department's designated office.

6. All documents are to be filed with the department's general counsel at the department's designated office.

7. Method of service, time of filing, and proof of mailing, the date of issues of an order, or a refusal to issue an order are governed by the chapter 281-6(17A).
