<u>Accounting Changes:</u> The rates contained in this agreement are based on the organizational structure and the accounting systems in effect at the time the proposal was submitted. Changes in organizational structure or changes in the method of accounting for costs which affect the amount of reimbursement resulting from use of the rates in this agreement, require the prior approval of the responsible negotiation agency. Failure to obtain such approval may result in subsequent audit disallowance.

<u>Provisional/Final/Predetermined Rates:</u> A proposal to establish a final rate must be submitted. Iowa's Part C Early ACCESS mission, guiding principles, and policies focus on teaming and collaborative practices which are dynamic and individualized to reflect the child and family's preferences, learning styles, and cultural beliefs. Providers are intentional in keeping families as full team members and experts about their child to ensure the early intervention services achieve the desired outcomes for the child and family. The State's commitment to family guided routines based interventions directly supports statewide system efforts toward long term implementation and sustainability of our mission and policies.

Additionally, Iowa is a birth mandate state whose services are provided to all children who meet eligibility requirements and their families. Our established infrastructure includes nine area education agencies as regional grantees in providing Part C Early ACCESS services. Administrators and liaisons from all nine agencies meet regularly to address system barriers. Their coordinated efforts, along with their knowledge and experiences, allow for fostering relationships with local community partners and ensuring all families are aware of Early ACCESS services. Furthermore, Iowa's Part C Early ACCESS system is overseen in partnership with two signatory agencies - University of Iowa-Child Health Specialty Clinics and Iowa Health and Human Services. These partnerships represent diversity in systems of nutrition, health, human services, and education.

The Iowa Department of Education, as lead agency, prioritizes equitable financial policies and practices through annual applications and an established payment/reimbursement process of IDEA Part C funding for our signatory agencies and area education agencies as local grantees. The Department's fiscal team is knowledgeable of program assurances, services, and allowable use of state and federal funding. They actively partner with agency leadership and support program staff regarding federal grants as well as state discretionary funding and activities. Likewise, the fiscal team has routine contact with local fiscal managers within signatory agencies and the area education agencies to provide technical assistance addressing fiscal topics.

2. Based on your proposed project or activity, what barriers may impede equitable access and participation of students, educators, or other beneficiaries?

Possible barriers which may impede equitable access and participation in Part C Early ACCESS include:

Iowa's rural geography and limited mass transportation may create challenges regarding families' knowledge of and access to available early intervention services. Fewer metropolitan areas or lower population density create situations of family isolation with fewer opportunities to learn about or receive services for their children and family. Unfortunately, many rural areas also struggle with insufficient internet access, which consequently poses barriers for virtual service options. Additionally, families may also be apprehensive to engage in receiving early intervention services, either as parents with less familiarity of typical child development and naivety of the early childhood system and/or an inherent caution of inviting professionals into their home with the family unit.

3. Based on the barriers identified, what steps will you take to address such barriers to equitable access and participation in the proposed project or activity?

To address the barrier of limited mass transportation, Part C Early ACCESS services are commonly provided in homes and other natural environments reducing the need for children and families to travel. With a similar intent, early intervention service providers also offer virtual services based on family preferences. Likewise, state and regional staff continue to support local efforts to establish and strengthen community partnerships to mitigate situations of family isolation and apprehension of services. To address family's potential apprehension about early intervention services; public engagement materials, including informational fliers and videos of providers and families describing services have been made available.

In a state effort, Iowa leaders continue to identify a means to expand broadband services across the state as funding and resources are available. To date, Iowa state leadership has utilized available federal funding for this purpose, however additional efforts are still needed.

4. What is your timeline, including targeted milestones, for addressing these identified barriers?

Historically, Iowa Part C Early ACCESS has shown an established practice of providing services in the child's natural environments; we continue to provide child and family focused services through various means based upon families' preferences.

State staff and partners continue to provide informational materials in public engagement efforts for current and future families receiving early intervention services. Ongoing communication and varying means of dispersing information remain a priority.

Similarly, we continue to coordinate regional and local community partners coming together annually to strengthen relationships and coordinate resources supporting families. Future efforts in this area include identification of and communication with additional potential partners to join ongoing activities with agencies providing Early Head Start and family support services. Finally, state staff continue to investigate how other Iowa state agencies serving families are addressing limitations with internet/broadband access in service delivery. We will continue to connect with state leadership regarding future plans and efforts to address this ongoing issue.
