Student Video Challenge Promotes Financial Literacy in Iowa *Challenge empowers students to educate peers on core concepts of personal finance*

Des Moines, IA, February 28, 2013 – The Iowa College Student Aid Commission (Iowa College Aid), in conjunction with Iowa Bankers Association and EverFi, Inc. are sponsoring the second annual IFLiP Video CLiP Challenge, a unique competition that encourages Iowa high school students to creatively demonstrate the importance of making smart financial decisions.

The challenge, which runs through March 30, 2013, asks students to submit videos, up to five minutes in length, to educate their peers on a financial literacy topic of their choice. Entries will be judged on overall impact, creativity, and accuracy of content. The team with the winning video will receive a \$1,000 technology grant for their high school, courtesy of Iowa Bankers Association, and \$250 for the student team members to share, courtesy of EverFi, Inc.

“Being financially aware and understanding how to manage money are invaluable skills for young adults,” stated Karen Misjak, executive director of Iowa College Aid. “Since the launch of the Iowa Financial Literacy Program thousands of students have accessed the award-winning program to explore and learn about core concepts of personal finance,” Misjak explained. “This challenge harnesses the talent of students and allows them to apply what they have learned to educate their peers in a format that is both creative and relatable to young people.”
